- Minutes of December 1, 2014 Faculty Senate Meeting

A motion was made by Robert Parkin to accept the December 1, 2014 Faculty Senate Meeting Minutes. It was seconded by Alan Doerr and passed unanimously.

## Graduate Policy and Affairs Committee (GPAC), (Robert Malloy)

- Proposal for a Graduate Certificate in Environmental Geoscience

A question was posted by David Lustick as to whether a course on Climate Change will be taught as part of this certificate. The petitioner, Nelson Eby, was unable to attend the meeting and therefore not able to provide a response. Nelson Eby will attend the April 6, 2015 Senate meeting to respond. The item was tabled for the time being.

- Proposal for Options in the Master of Public Health (MPH)
  - a. Gerontology
  - b. Healthcare Management
  - c. Nutrition
  - d. Population Health

Associate Dean Houde provided an overview of the options. A motion was made to accept the proposal. It was seconded and passed unanimously.

- Proposal for a Graduate Certificate in Pharmaceutical Sciences Associate Dean Houde provided an overview of this certificate. It is helpful as a conduit into the degree program. A motion was made to accept the proposal. It was seconded and passed unanimously.
- Proposal for a Graduate Certificate in Field Programmable Gate Array Martin Margala presented this proposal. He indicated that students have expressed interest in this certificate. A motion was made to accept the certificate. It was seconded and passed unanimously.
- Proposal to change course requirements in the PhD in Engineering: Plastics Engineering Option Robert Malloy provided an overview of the changes. Each department in Engineering has its own option. Some years back changes instituted were not very unified. These changes will unify the requirements. There will be no change in the number of credits. A motion was made to accept the changes. It was seconded and passed unanimously.

## Undergraduate Policy Committee (UPC), (Arthur Mittler)

Proposal to add a Data Science Option for Computer Science Majors
 Ekaterina Saenko provided an overview of the option. The option consists of six courses – four
 required courses and two electives. The option will appeal to students who are strong in both
 Mathematics and Computer Science. A motion was made to accept the proposal. It was seconded and
 passed unanimously.

## Core Curriculum Committee (CCC), (Michael Graves)

- Michael Graves, chairperson, provided an update on the committees' work in reviewing courses submissions for the new Essential Learning Outcomes (ELO) requirements. The process is working well. Courses are sent back often requesting clarification on how the ELO is being met. There are three members on each subcommittee. Keith Mitchell inquired as to whether the work will be up to date in the Fall of 2015. Vice Provost Mandell indicated that for the most part the ELO's are in the upper level courses. She proposed that transfer students be placed on the old system. This may be up to the department. Michael Graves will send the link to the College Coordinators and ask that they send to all faculty in their respective departments.

## Other Business

- Faculty Senate By-Laws

Faculty was asked to look the document over. Final discussion of the By-Laws will take place at the April 6, 2015 Faculty Senate meeting. Michael Carter thanked Martha Burns for her work on the Faculty Senate. His comment was greeted with thunderous applause and whistling.

- Spring 2015 Faculty Senate Election Guidelines, Faculty Senator Listing with 2015 and 2016 term ends

Martha Burns will be contacting Department Chairpersons requesting "replacement/re-elect" Faculty Senators for Senators whose terms end at the April 2015 Faculty Senate Meeting. Replacement/re-elected Senators begin their two year term at the May 2015 Senate Meeting.

Faculty Senate President Michael Carter provided an update on the budget. There is a huge budget deficit in Massachusetts. He indicated that he is on the Budget and Planning Committee but a budget for next year has not been developed yet. There is no threat of layoffs coming. We anticipate that the year will end with a slight budget surplus.

Michael Carter also indicated that relative to Faculty Contracts the union is setting up a meeting with the Chancellor and the Provost to discuss.
