1. Minutes of March 4, 2013 Faculty Senate Meeting
A motion was made by Marie Frank to approve the March Faculty Senate meeting minutes. It was seconded by Bob Parkin and passed unanimously.

2. Graduate Policy and Affairs Committee (GPAC), (Professor Sherwood)

- Proposal for an Option in Healthcare Innovation and Entrepreneurship in the MSITE Degree Yash Puri presented this proposal stating that the intent is to establish a separate option which will focus on the healthcare profession only. A motion was made to accept the proposal by Marie Frank. It was seconded by Eve Buzawa and passed unanimously.
- Preliminary Proposal for a Master of Science in Finance
   Yash Puri provided background on this program designed for people who are in finance careers.
   A motion was made by Ann Marie Hurley to accept the proposal. It was seconded by James Egan and passed unanimously.
- Proposal for a Certificate in Professional Leadership Vice Provost Pierson provided a brief overview of this certificate. A motion was made by Bob Parkin to accept the proposal. The motion passed with one abstention.
- Proposal for a PSM option in the M.S. in Pharmaceutical Sciences
  Associate Dean Houde presented the proposal indicating that during the review process adding
  this option was recommended. James Egan made a motion to accept the proposal contingent
  upon final approval of the M.S. in Pharmaceutical Sciences by the Board of Higher Education. It
  was seconded by Bob Parkin and passed unanimously.
