The meeting convened at 3:40 PM.

1. Minutes of May 7, 2012 Faculty Senate Meeting, Attachment 1 It is noted that a final sentence should be added to Item 3 as follows:

"Relative to Teaching Assignments, Provost Abdelal indicated that assigning Teaching Assistants to doctoral students is favored but not required."

A motion was made to accept the minutes as edited and passed unanimously.

Provost Ahmed Abdelal

Provost Abdelal provided good news about UMass Lowell's national ranking. It is particularly significant that we have advanced for three years in a row. Not all universities are advancing. In 2012, UMass Lowell tied with seven other institutions at #177 (34th percentile), and in 2011 was at #166 tied with seven other universities (29th percentile). Faculty and staff have made significant contributions to our advancement.

2. Reports, (Vice Provost Mandell)

Vice Provost Mandell announced that a new survey on faculty job satisfaction – COACHE – is forthcoming and will be distributed to all tenured and non-tenured faculty. Announcements will come via "UML Today" e-mail.

a. National Survey of Student Engagement, (NSSE)

Vice Provost Mandell noted that enormous strides are being made in the area of diversity. Relative to peer and peer aspirant institutions our freshmen are less satisfied with their academic advising experience. However, our seniors are satisfied with their UMass Lowell experience.

b. STARFISH

Vice Provost Mandell stated that STARFISH is a tool which assists with student retention.

c. New England Association of Schools and Colleges, (NEASC) The next NEASC draft is due by the end of October.

3. Digital Measures/Activity Insight, (Vice Provost Chen), Attachment 2

Vice Provost Chen announced that last year we attempted to assemble a booklet summarizing faculty accomplishments but the method of obtaining information meant that numerous e-mails had to be sent. We have been trying to come up with a way to get all the information together perhaps using some kind of template. Digital Measures is used by a lot of other universities and is customizable. Implementation will involve obtaining Faculty CV's and inputting them into the system. Once a CV is in place a faculty member can very easily go into the system and add data using a drop-down menu.

 Michael Carter presented the Mission Statement. A motion was made to approve the statement. All members with the exception of one, who abstained, approved the motion.
- 6. Budget Projects and Contingency Planning, (Professor Carter), Attachment 4
 Michael Carter provided a report on Capital Budget Projects approved at the recent A&F meeting of the Board of Trustees. He also noted that campus A&F departments have been instructed to prepare contingency funding plans to be implemented under varying possible scenarios of cutbacks in state support cutbacks. There will be another meeting of the Board to discuss the campus plans on October 16th. Eve Buzawa will attend and report on that Board meeting at our next senate meeting.
- 7. Graduate Policy and Affairs Committee (GPAC), (Professor Sherwood), Attachment 4
 - a. Fast Track MS to DNP Program, Attachment 5 Angela Nannini provided an overview of the MS to DNP Program. A motion was made to accept the program. It passed unanimously.
- 8. Policy on "Schools Within Colleges," (Professor Carter), Attachment 6
 Michael Carter presented an overview on the process for conversion of some large research intensive academic departments to "Schools Within Colleges." Eve Buzawa then presented Criminal Justice's conversion into the School of Criminology and Social Justice as an example. Following the discussion Karen Melillo, citing the accomplishments of the Nursing department, gave a report on progress being made on establishing a School of Nursing that would function as a College with its own Dean.

The concept of "Schools Within Colleges" was placed on the agenda for information to avoid confusion of Schools <u>within</u> Colleges with <u>stand alone</u> Schools that are in fact Colleges. The faculty senate does not vote on administrative decisions concerning departmental structural change, unless such change impacts the content of academic programs delivered by the department.

9. Other Business

a. Cool Science, www.coolscience.net, (Professor Lustick), Attachment 7

David Lustick was unable to make the meeting. Vice Provost Chen provided an overview of this grant. It features a Climate Change Science Art competition for all K through 16 Massachusetts students, where winning artwork will be displayed on Lowell's mass transit system.
