- Minutes of May 5, 2014 Faculty Senate Meeting

A motion was made by Robert Parking to accept the April 7, 2014 Faculty Senate Meeting Minutes. It was seconded by Alan Doerr and passed unanimously.

Graduate Policy and Affairs Committee (GPAC), (Barbara Mawn)

- Final Proposal for a Master of Science (MS) in Engineering Management Sammy Shina provided an overview of the proposal. A motion was made to accept the proposal. It was seconded and passed unanimously.

- Final Proposal for a Master of Arts (MA) in History Lisa Edwards provided an overview of the proposal. A motion was made to accept the proposal. It was seconded and passed unanimously.
- Proposal for a Service-Learning Course Attribute Policy and Form Barbara Mawn presented on behalf of Robin Toof. Kerry Donohoe noted that the indication of a service learning attribute allows the university to more accurately report.
- Proposal for a Certificate in Public Health Studies
 Associate Dean Houde provided an overview. A motion was made to accept the proposal. It was seconded and passed unanimously.
- Proposal for Curriculum Changes to the PhD in Business Administration
 Yi Yang provided an overview noting that the reduction in the number of credits brings the university
 more in line with peer and aspirant institutions. Two concentrations will undergo name changes. A
 motion was made to accept the proposal. It was seconded and passed unanimously.
- Proposal for an Articulation Agreement between the University of Massachusetts Lowell Department
 of Work Environment and Keene State College Department of Safety and Occupational Health
 Applied Sciences
 Bryan Buchholz provided an overview of this agreement indicating that this agreement is intended to
 encourage students in the KSC Safety and Occupational Health Applied Sciences Bachelor of Science
 program to matriculate in the UML Work Environment Master of Science program.

Report from the Faculty Representative to the Board of Trustees

- President Caret reported 72,000 applications, 13,300 new students, 2.3% increase in enrollment, and SAT and GRE scores are up. He will listen to union concerns and try to resolve contracts. \$117 million in endowment raised (12% over goal). He is going on his 4th annual bus tour starting October 7 with a focus on the impact of alum on community. UMass Amherst is in top 30 for public institutions in country (up 10 spots). It is UMass Boston 50th birthday. New degrees at UMass Boston include MPA and PhD in Global Comparative Public Administration, MS in Urban Planning and Community Development, PhD in Early Child Education and Care, EdD and PhD in Leadership in Urban Schools, at UMass Dartmouth an MS in Technology Management, MS in Accounting and at UMass Lowell a Doctor of Pharmacy.

Report on the A&F Committee Meeting

The Trustees approved three new Endowed Professorships in the College of Engineering. Most of the meeting was taken up with discussion of capital plans. UML's ambitious capital spending plan is projected to push the ratio of our debt service to operating revenue up to the 8% ceiling imposed by the Trustees by fiscal 2018. (This is still below the 10% level at which bond rating agencies start to lower institutions bond rating. The Trustees are very concerned to retain the high bond rating of UMass, and all campuses are instructed to stay at or below the 8% threshold.) In addition to capital projects already in various stages of construction or completed, future projects include additional new student housing, substantial deferred maintenance and renovation of older buildings on North and South campus, a new School of Business Building on North, a new dining hall on South and a complete redesign and repurposing of McGauvran on South. The newest major project to win approval is a \$35 million, 55000 square foot addition to the Tsongas center so that our DIV 1 hockey and Div 1 Mens &

Women's basketball teams have adequate practice facilities while more time slots are opened up at the main Tsongas center to host revenue generating events.
